Fee Schedule

COURT-SPONSORED MEDIATION FEES

All fees will be paid on a *pro rata* basis unless otherwise agreed by the parties. There will be a three-hour minimum with a fee schedule as follows:

\$150 per hour for the first two (2) hours (i.e., \$300 total)

\$360 for every hour thereafter

Services include preparation time, case administrative fees and expenses.

Initial Deposit

Unless otherwise agreed by the parties, each party will pay its pro ration of \$660 for the first three (3) hours of mediation. To hold the designated date, all parties must pay their portion of the \$660 deposit one week prior to the scheduled mediation.

Cancellation Policy

- If mediation is cancelled more than 48 hours before its scheduled date, there will be a \$150 administrative fee assessed, and the balance of the \$660 deposit (i.e., \$510) will be returned to the parties.
- If mediation is cancelled within 48 hours of the scheduled date, there will be a \$300 cancellation fee, and the balance of the \$660 deposit (\$360) will be returned to the parties.

PRIVATE MEDIATION FEES

Full-day Cases

\$2700

Services include preparation time, eight hours conference time, case administrative fees and expenses.

Half-day Cases

\$1400

Services include preparation time, four hours conference time, case administrative fees and expenses.

Hourly Rate

\$360

Mr. Barker's hourly rate for mediation is \$360.

Cancellation Policy

All cancellations or postponements must be received by Barker Mediation five working days prior to the scheduled mediation date or a cancellation fee of \$300 may be assessed.
